#### LIFT Conversation Starter – Hiring a Tax Advisor

Certified Professional Account. That sounds expensive doesn't it?

CPA. Ouch, the profession even has an acronym. There is no way you can afford one of those in your business.

Fact is, you probably can't afford to NOT have one working for you in your business. Personal taxes are tough enough to navigate your way through, never mind trying to figure out how to do your business taxes.

Fair enough, maybe you can manage to complete your taxes with a lot of hair pulling and mumbling under your breath, but did you manage to complete them with all of the possible deductions available to you? Did you do the research so you can start living the entrepreneurial lifestyle with all of the included benefits?

Entrepreneurial lifestyle? What is this entrepreneurial lifestyle we speak of?

Writing off trips, meals, hotels, computers, theatre tickets, golf games, seminars, magazines; the list goes on, and it is all part of the new entrepreneurial lifestyle you should be living. It is one of the biggest benefits of running your own business and a CPA can help you structure your life and business to take maximum advantage of the tax laws and increase your deductions.

If done correctly, with the help of the right CPA, you should probably only be paying about 10% of your business income in taxes. #### **Conversation Starter and LIFT Profile**

To start building a strong relationship with a new CPA (or with your current CPA if you have one) follow these steps:

- 1. Make appointments with three different CPAs to have this conversation. If you already have a CPA include him or her in this process.
- Ask each CPA the questions included in the Conversation Starter below.
- 3. Keep track of the answers while talking with each CPA. You wont remember them later.
- 4. When the meeting is over write down your overall impression of each CPA.
- 5. Once you select your CPA transfer the information from the Conversation Starter to the LIFT Profile Tax Advisor sheet.
- 6. Use the LIFT Profile Tax Advisor sheet to have a follow up conversation with your selected Advisor and fill in any missing information.

How will you help me with setting up/reviewing my monthly and quarterly reports?

How will you help me determine what reports I need to generate for my business? My investors?
How many times a year do you believe we should meet?
When do you think we should meet each year?
How often should we meet to do tax planning and figure out how to maximize my deductions?
How will you help me with proactive planning for my business and taxes?
How will you help me determine financial projections for my business?

Explain your expectations for working with them then ask: Can you provide these types of services to my business?
What is your process for preparing and filing my tax returns?
Are you flexible on the year end for my business?
How far in advance do you need my information to prepare my taxes?
Do you assist me with my estimated tax payments?
Do you assist me with my payroll taxes?

How do you charge for your services?
Do you operate under a flat fee?
What services are included in your flat fee?
Do you operate on an hourly fee?
What services are charged hourly?
Do you charge per phone call? How much?

Do you charge for emails? How much?
